As per SEBI Circular Ref No. **SEBI/HO/DEPA-II/DEPA-II_SRG/P/CIR/2025/86** dated June 11, 2025, we have enabled a **structured UPI mechanism** for safe and direct fund transfers. This mechanism provides investors with the option to transfer funds directly to the bank account of **ANJANEY STOCK BROKING LTD** while making payments for investments and/or demat charges through UPI mode.

The QR code generated using the utility will have a **“white thumbs-up icon inside a green triangle”**. It will also display the UPI ID just below the QR code. It is envisaged that the above icon will further assure the investors that the payments are being made to the verified registered market intermediaries and at the same time its absence would caution investors of the risk that they are making payments to unauthorised entities.

In order to provide an additional layer of security and help investors verify the authenticity of an entity before proceeding with any financial transaction, SEBI has developed a functionality named **“SEBI Check”** on its website.

This functionality will allow investors to verify the authenticity of UPI IDs either by scanning a QR code or by entering the UPI ID manually.

This tool will also include a feature to confirm the bank details such as bank account number and Indian Financial System Code (IFSC) of an intermediary.

The below UPI ids and QR Codes have been validated with SEBI for receipt of funds from the investors through UPI in a safe and secured manner. Please prefer to use them for making your payments secure.
